ADMINISTRATION OF THE EARLY LANGUAGE, LITERACY, AND NUMERACY ASSESSMENT FOR SCHOOL YEAR (SY) 2024-2025

To: Public Schools District Supervisors
District Coordinating Principals
Elementary School Heads
All Others Concerned

- 1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), will administer the **Early Language. Literacy, and Numeracy Assessment (ELLNA) for school year 2025-2026**, pursuant to DepEd Order (DO) No. 55, s. 2016, titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, on **November 3-7, 2025**, as the testing window for all public elementary schools.
- 2. The administration of ELLNA is pursuant to DO 029, s. 2022, titled Adoption of the Basic Education Monitoring and Evaluation Framework, as it measures the level of proficiency of key stage 1 learners in terms of language, literacy, and numeracy.
- 3. The ELLNA is to be administered at the end of key stage 1 to determine if learners are meeting the learning standards in early language, literacy, and numeracy. Thus, the ELLNA shall be administered to all **Grade 4 public elementary learners**.
