Diwata ES, I kindly request a temporary redeployment of teachers to nearby schools until the environmental and life-threatening concerns are adequately addressed. Our primary goal is to ensure the safety of both the teachers and the learners, and I believe that this temporary relocation would serve this purpose effectively.

Noting that there is a current gold tunnel operating near the school.

Said teachers shall temporarily report to Depot ES and Munoz ES as temporary arrangements while waiting for the solution of the issues and concerns of our school's current situation.

Blended learning shall be applied to learners while teachers are on their temporary school – base.
