

b.4) Approve Purchase Request (FR), Purchase Order (FO), Obligation Request (OBR), Request for Cash Advance for School Maintenance and Other Operating Expenses (MOOE), Disbursement Voucher, not exceeding Three Hundred Thousand Pesos (P300,000,00), and Liquidation Report;

b.5) Approve/sign Obligation Request and Disbursement Voucher for monthly

payroll of employees;

b.6) Approve/sign List of Due and Demandable Accounts Payable-Advice to Debit Account (LDDAP-ADA), Advice of Checks Issued and Cancelled (ACIC), and Payroll Crediting System Validation (PaCSVal);

b. Y) Approve/sign Request for Funding Requirements to DBM and other similar

financial requests and/or reports;

B.8) Approve/sign Provident loan not exceeding One Hundred Thousand Pesos

(P100,000,00); and
