DEVELOPMENT OF A PUBLIC SERVICE CONTINUITY PLAN (PSCP)

To: Concerned Division Personnel Head of Sections

- 1. Relative to the National Disaster Risk Reduction and Management Council Memorandum No. 33, s. 2018 entitled Public Service Continuity Plan (PSCP) Template for Government Agencies and Pursuant to the Office of the President of the Philippines Cabinet Action / Decision File No. 381-120517-34 and the 4th Meeting of the Cabinet Cluster on Climate Change Adaptation, Mitigation and Disaster Risk Reduction, recommends all government agencies to have their respective PSCP to guarantee the continuity of operations amidst disruptions.
- 2. The development of a Public Service Continuity Plan (PSCP) is a critical component of organizational management that involves preparing for and responding to potential disruptions in the delivery of public services. The plan is intended to help the government function and provide essential services continuously, particularly during disasters and emergencies.
- 3. Significantly, establishing a PSCP ensures the continuity and equitable access to educational services, even during disasters and emergencies.
- 4. Anent to this to this mandate, the Schools Division of Davao de Oro will conduct a Three (3) days live-in Seminar Workshop on the Development of Public Safety Continuity Plan on October 16-18, 2023 at the Ritz Hotel- Garden Oases, Porras Street, Bo. Obrero, Davao City.
