This input is crucial for comprehensive data analysis and ranking within the region.

Moreover, schools are advised to be ready with NS Baseline Reports and WINS Reports at any time since the validation process will be unannounced. This approach is meant to capture the most accurate data and ensure that the reports are a true reflection of the current nutritional status of our learners.
