## BOLA TA DOT INTER-AGENCY BASKETBALL TOURNAMENT

### MECHANICS

#### BASKETBALL

##### A. General Rules

1. All participating teams shall submit a lineup of 12-15 players, together with the designated coach and assistant coach on or before the agreed date. Players not included in the list shall not be allowed to play.
2. Changes in the line-up shall no longer be entertained when the tournament has already started its first game.
3. Team coach shall be responsible for his own team's conduct and behavior in and out of the court.
4. Current FIBA rules shall apply.
5. Basketball tournament shall be in one (1) categories, only:
  - a. Inter-Agency/By Cluster
6. Players should have played during the elimination games for him to play the championship and final game.

##### B. ELIGIBILITY OF THE PLAYERS

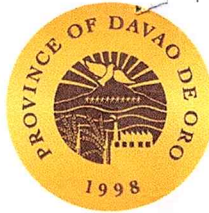
###### \* Inter-Agency/By Cluster

1. Players must be a bonafide employee in particular agency.
2. He must be a regular and Job Order.
3. For above 40 years old player, must provide medical certificate.
4. No GIP/EAP/SPES is allowed to play.

##### C. Tournament Format and Other Technical Rules

1. Format for the tournament are as follows:  
Teams will play by single elimination to determine the top four (4) teams to qualify for final round.

- Top two (2) Teams will play in the Championship round.

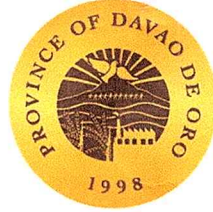
