In the absence of such attire, any accent or accessories related to the chosen country may be worn during the whole duration of the activity.

Participants shall be entitled to service credits in accordance with DepEd Order 53, s. 2003 entitled. Updated Guidelines on the Grant of Vacation Service Credits to Teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time-Off (CTO) as per Civil Service Commission (CSC) and department of Budget and management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
