
**A registration of Php 6,500 will be collected from each of the participant of this course. The inclusions are:**

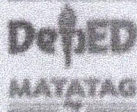
- a. Certificate from PNVF

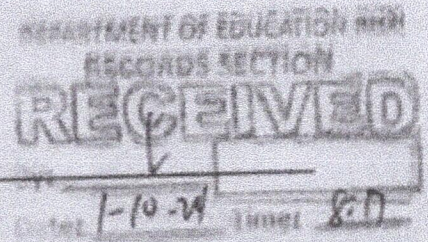


