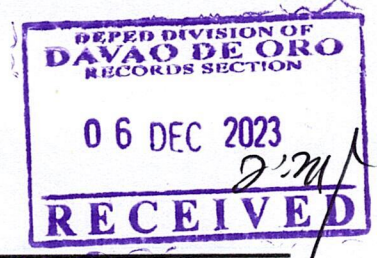

CORRIGENDUM TO DIVISION MEMORANDUM NO 738, S. 2023: SCHOOL-BASED FEEDING PROGRAM (REGULAR COMPONENT) SY 2023-2024 IMPLEMENTATION

1. Relative to the series of earthquakes experienced in the Province of Davao de Oro, suspension of classes and work in schools was ordered and would remain pending until results of the structural integrity assessments conducted by all local government units (LGUs) in the province.
2. In line with this, the distribution of School-Based Feeding Program (SBFP) commodities is rescheduled to take place on December 5-6, 2023, shifting from the initially planned dates of December 4-5, 2023, this to give way for the LGUs to check the structural integrity of the schools and workplace.
3. Owing to the recent seismic activity in the Province, there is a need to change the distribution of Nutritious Food Products. The school is tasked with developing a strategic plan to efficiently distribute the delivered food products to the intended beneficiaries. Presented below are potential options for the school to consider implementing in response to this situation:
 - a. Parents/Guardians are encouraged to claim the NFP commodity from the school.
 - b. School Personnel may opt to distribute the NFP commodity from the school to beneficiary residences.
 - c. School may partner with Barangay unit to assist for the distribution of NFP to beneficiaries.

4. In cases that the suspension of work is not yet lifted locally, the personnel who will participate in receiving and distribution of the Nutritious Food Products shall be granted equivalent Service Credits.
5. Further, requirements needed in claiming Service Credits must be submitted to your respective Elementary District Nurses.
