

Contract Agreement Form for the Procurement of Goods

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of 27 DEC 2023 20____ between **DEPARTMENT OF EDUCATION- DIVISION OF DAVAO DE ORO** of the Philippines of the one part and **ZION ACCUPRINT PUBLISHING INC.**, Door 14, ALCREJ Bldg., E. Quirino Ave., Brgy. 4-A, Poblacion District, Davao City, Philippines, of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PRINTING & DELIVERY OF BRIDGING PRIMER 2 LEARNING RESOURCES (SDDO-016-2023)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Hundred Forty-Six Thousand Seven Hundred Seventy-Four Pesos and Thirty Centavos (P 546,774.30)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of the Contract;
 - iv. Supplemental or Bid Bulletin, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.

documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Five Hundred Forty-Six Thousand Seven Hundred Seventy-Four Pesos and Thirty Centavos (P 546,774.30)**, or such other sums as may be ascertained, **ZION ACCUPRINT PUBLISHING INC.** agrees to particularly **PRINTING & DELIVERY OF BRIDGING PRIMER 2 LEARNING RESOURCES (SDDO-016-2023)** in accordance with his/her/its Bid.

4. The **DEPARTMENT OF EDUCATION DIVISION OF DAVAO DE ORO** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
