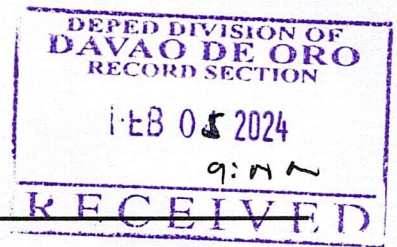

**SCHOOL-BASED FEEDING PROGRAM DURING MID YEAR PROGRAM REVIEW  
 AND EVALUATION (MPRE)**

1. To avoid interruption of the School-Based Feeding Program (SBFP) during the Mid-Year Program Review (MPRE), it is advised that beneficiaries may take home the Nutritious Food Products scheduled for distribution on MPRE.
2. Delivery of NFP will be moved to January 22, 2024 instead of January 22-23, 2024, and January 31, 2024, instead January 29-30, 2024. This change aims to ensure there is enough time for the efficient distribution of NFP to the beneficiaries.
