

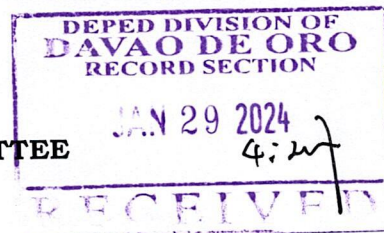

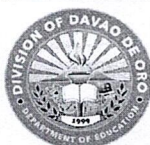


RECONSTITUTION OF DIVISION SELECTION COMMITTEE

Secure list of its LGU-funded teachers from the office of the provincial governor, city/municipal mayor, or provincial/city/municipal administrator. 9. Ensures that LGU-funded and volunteer teacher applicants go through the application process as provided for in these guidelines. 10. Submits the complete results of the evaluation of applicants, including pertinent records of deliberations, to the SDS for approval.

2. This designation does not carry with it additional remuneration nor a priority in promotion and takes effect immediately upon the date of effectivity and will remain enforced until revoked by the competent authority.
3. All previous issuances that are contrary to this memorandum are hereby rescinded.
