3. Service Credits or Compensatory Overtime Credits (COC) shall be granted to the teaching and non-teaching personnel for the services to be rendered during the Holiday, Saturday, and Sunday as per DepEd Order No. 53, s.2003.
4. Travel, meals, and other incidental expenses of the personnel shall be charged against Division/School funds, subject to the usual accounting and auditing rules and regulations.

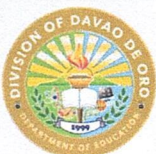
