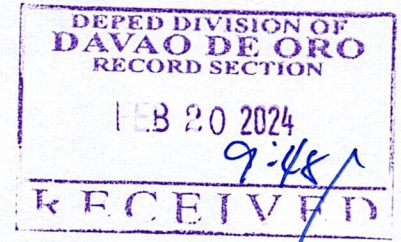

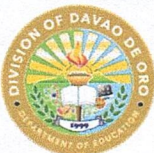

This Office hereby informs the field to establish a District Learner Rights and Protection Desk in the billeting quarter during the Provincial Meet.

 - b. Reporting Form 2: Incident Report
 - c. Reporting Form 3: Consolidation of Child Protection Cases(Daily)

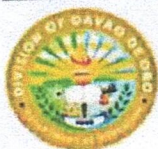
