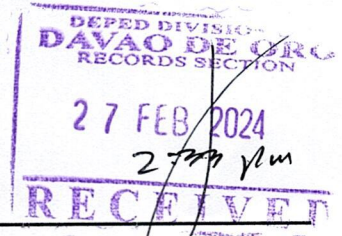

2. The Philippines, situated along the Pacific Ring of Fire and the Typhoon Belt, is exposed to natural hazards such as typhoons, earthquakes, volcanic eruptions, and tsunamis. Furthermore, human-induced hazards such as crimes, terrorism and bombing also threaten the lives of the Filipino. With the enactment of Republic Act 10121, the National Disaster Risk Reduction and Management Council (NDRRMC) has been leading the efforts to reduce the country's risks on earthquakes and other geologic hazards through interventions of disaster preparedness activities, such as drills and exercises.
3. One of the N/RDRRMCs distinct programs is the conduct of the quarterly Nationwide Simultaneous Earthquake Drill (NSED) under the direct facilitation of the Office of Civil Defense (OCD).
4. In view hereof, the schedule for the CY 2024 Quarterly NSED and Observance of the World Tsunami Awareness Day is hereby disseminated, to wit:

SUBJECT: Re-Scheduling of the First (1st) Quarter NSED 2024 and Amending for the Purpose NDRRMC Memorandum No. 013, s. 2024

NDRRMC Memorandum No. 013, s. 2024, dated 24 January 2024, provided for the schedules for the conduct of CY 2024 Quarterly Nationwide Simultaneous Earthquake Drill (NSED). Wherefore, pursuant to Section 09(i) of RA 10121, the Office of Civil Defense (OCD) is tasked to *establish Disaster Risk Reduction and Management Training Institutes in such suitable location as may be deemed appropriate to train public and private individuals, both local and national, in such subject as disaster risk reduction and management among others...*

Anent the said statutory provision, it has been part of the continuing agenda of the OCD, the NDRRMC, and of the DRRM practitioners to finally realize the establishment of the Institute. With this, in accordance with OCD Memorandum NO. 011, s. 2024, the Civil Defense Training Institute (CDTI) was reactivated and is set to be launched on **14 March 2024 (0900H)**, which will be attended by the NDRRMC member agencies, DRRM stakeholders, other partners, and the OCD Regional Offices representatives.


In view of the scheduled launching of the CDTI which coincides with the date of the First (1st) Quarter NSED, NDRRMC Memorandum No. 013, s. 2024 is **HEREBY AMENDED**. For which, the First (1st) Quarter NSED 2024 is therefore moved from 14 March 2024 (09:00 AM) to 25 March 2024 (09:00 AM).

The rest of the schedules are retained on their original dates, unless otherwise amended. Active participation of DRRMCs at all levels, including the Barangay DRRMCs, as well as the National Government Agencies and other Government entities is strongly encouraged.

SUBJECT: Conduct of the CY 2024 Quarterly Nationwide Simultaneous Earthquake Drill

Rule 6, Section 7 of the Implementing Rules and Regulation of the RA 10121 states that "Public awareness shall also be undertaken through the conduct of drills by the LDRRMO on a regular basis". Likewise, the National Disaster Risk Reduction and Management Plan states that one of the activities to achieve Outcome 10: "Developed and implemented comprehensive national and local preparedness and response policies, plans, and systems" is also to develop/enhance and simulate scenario-based preparedness and response plans. Furthermore, one of the policy frameworks stated in the National Disaster Preparedness Plan as embedded in the fourth priority area of the Sendai Framework for Action 2015-2030 includes the target: to promote regular disaster preparedness, response and recovery exercises".

NDRRMC Memorandum No. 06 s. 2023 allowed the resumption of the conduct of traditional or in-person Nationwide Simultaneous Earthquake Drill (NSED) beginning from the first quarter of 2023. It is therefore recommended that aside from evacuation drills, other forms of exercises may be designed and implemented based on needs assessment, to scale up the overall earthquake preparedness of your chosen sites.

In view thereof, the schedule for the CY 2024 Quarterly Nationwide Simultaneous Earthquake Drill (NSED) and the Observance of the World Tsunami Awareness Day is hereby disseminated:


