Subject: MEDICAL TEAM DURING IN-HOUSE TRAINING OF DAVAO DE

ORO ATHLETES

1. Attached herewith is the schedule of health and nutrition personnel duty for the in-house training of the Davao de Oro athletes on March 17-30, 2024 at Pantukan, Davao de Oro.

- 2. Medical team are expected to ensure the health and safety of the athletes/ coaches and delegation officials. Some tasks and responsibilities of the team include but not limited to:
 - a. Provide immediate medical attention and intervention in case of injuries or emergencies to athletes, coaches, technical officials/ staff;
 - b. Assessing and treating minor injuries;
 - c. Coordinate with emergency services if further medical assistance is required;
 - Collaborating closely with coaches, strength and conditioning staff, and other support personnel to ensure a holistic approach to athlete health and performance; and,
 - e. Keeping accurate records of injuries, treatments, and medical interventions, and ensuring that this information is communicated effectively within the medical team and to coaches as needed.
- 3. Compensatory Overtime Credits (COCs) will be granted to the personnel rendering services that fall on Saturday, Sunday and those beyond office hours as per DepEd Order No. 53, s. 2003.
- 4. Transportation and other incidental requirements shall be charged against Division MOOE subject to usual accounting rules and regulations.
- 5. Immediate dissemination of this Memorandum is desired.
