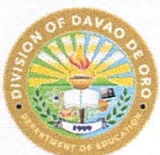

Subject: DEPED ONSE CARES: BRIGADAHAN SA ESKWELAHAN

Date : February 6, 2024

The Regional Office recognizes the devastation and degree of difficulties of learners and personnel during the onslaught of heavy rains due to trough of LPA which brought flooding and landslides.

With the recent development on the Rapid Damages and Needs Assessment, this Office identifies six Schools Division Offices as heavily affected by the calamity.

In view thereof, SDOs least affected are advised to organize assistance through cash/in-kind donations; provide Mental Health and Psychosocial Support Services (MHPSS) including Psychological First Aid (PFA); and help affected schools division in cleaning and restructuring and provision of SLMs for learners to continue education. This project will be dubbed DepEd Onse Cares: Brigadahan sa Eskwelahan.

Anent to this, the following will be the clusters for the provision of assistance:

Office/SDOs	Partner

Further, ESSD and SGOD through DRRM coordinators, engineers, and health personnel shall immediately convene to discuss the details of the activity, including timelines, recommendations, and others.

In addition, provision of MHPSS and PFA to affected learners and personnel shall be conducted with the partner Office/SDOs through their respective School Mental Health Team or PFA Team immediately.
