FIRST ONSITE SESSION**

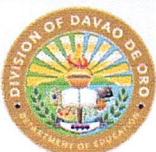

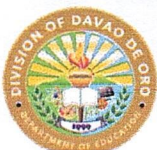

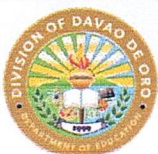
