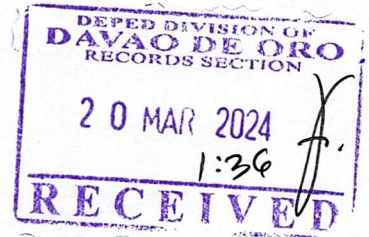

- d. Ensuring that all necessary medical supplies and equipment are available.

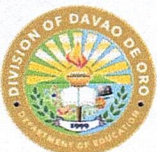
3. Attached herewith is the list of Medical Team.

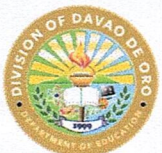
