- 4) Immediate dissemination of this memorandum is directed.

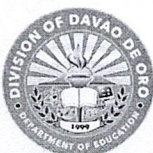

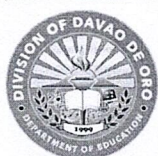



A registration fee of One Thousand Pesos (P1,000.00) shall be collected to defray necessary expenses.


