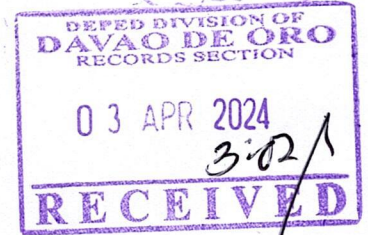

CONDUCT OF TEACHER REFLECTION ASSESSMENT TO TEACHER 1 APPLICANTS

TO: Education Program Supervisors
 Public Schools District Supervisors
 District Coordinating Principals
 Elementary and Secondary School Administrators
 All Others Concerned

1. Pursuant to Relative to DepEd Order 007 s. 2023 otherwise known as the Hiring Guidelines on the Recruitment, Selection and Appointment in the Department of Education, this instruction relative to the conduct of Teacher Reflection Assessment to Teacher I Applicants is hereby issued.
2. In consideration of the prompt and orderly release of the School Year 2024-2025 Registry of Qualified Applicants the following shall be implemented to wit:
 - 2.1. The applicant's demonstration of PPST Non-Classroom Observable Indicators (PPST NCOIs) which shall be assessed through the applicant's narrative and reflection using the Teachers Reflection Form (TRF) will be scheduled on **April 6, 2024 @ 8:00AM-12:00NN**. Applicant who belongs to the Seventh Day Adventist may take the test on **April 7, 2024** at the respective District Offices. Public Schools District Supervisor and District Coordinating Principals will assign selected TRF Evaluators for this purpose.
 - 2.2. It is expected that all applicants (Old and New) shall take the assessment of PPST NCOI at the following venues/ testing centers of the district where the school they applied belong, to wit:

- 2.3. There are four (4) non-classroom observable indicators with respective situations for the applicant to express his/her view and reflection in a narrative format based on his/her experiences as guided by prompt questions. The TRF shall be accomplished on the spot. **The applicants shall be given one (1) hour to accomplish the complete set of the Teacher Reflection Form.**
 - 2.4. Rubrics for rating the TRF (*Enclosure 1*) is used to rate the teacher applicant's responses by the selected TRF evaluators (*Enclosure 3*) who possesses deep understanding and knowledge of the PPST NCOIs and are subject matter experts on the specialization of the position to be filled. These evaluators will also serve as proctors during the assessment day.
 - 2.5. Scoring Template in Enclosure 2 will be used for the summary of rating to be attached to the individual Teacher Reflection Form (TRF).
 - 2.6. The Education Program Supervisors (*Enclosure 4*) will serve as the Test Administrators and will be responsible for the distribution and retrieval of the accomplished Teacher Reflection Form.
 - 2.7. Rating shall be submitted to the HRMPSB Secretariat – *Milagros Revilleza or Marivic Endaya* five (5) days after the conduct of the assessment. These results shall be forwarded to the Division Sub-committee for posting in the DOORS system.
3. District Supervisor and District Coordinating Principal may issue a District Memorandum in an orientation will be done prior to the conduct of the assessment. Service credits shall be given to personnel who will participate in this activity.
 4. Travel and other incidental expenses shall be charged to MOOE or any local Funds subject to the usual accounting and audit procedures.
 5. Wide dissemination and compliance with this memorandum is desired.
