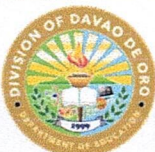

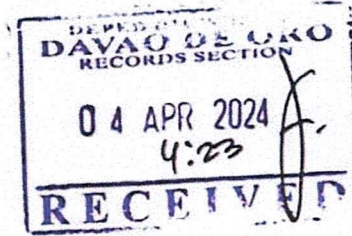

This year, the evaluating team will be utilizing the newly developed MELLPI Pro Tool in evaluating Nutrition Program accomplishment.


