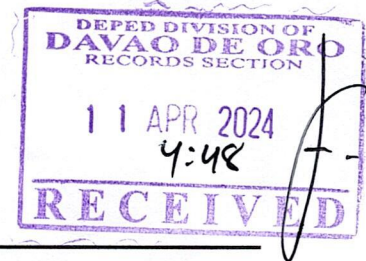

VALIDATION IN BONGBONG ELEMENTARY SCHOOL**

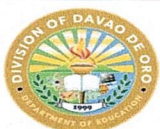
